### **WORK SESSION**

Supervisor Hay made a motion to open the work session. All in favor.

### Discussion – Geese

There was a discussion on how to handle the geese population and the public health concerns of their feces without shooting them to remove them. The dead geese are then taken to a wolf preserve and used to feed the wolves. Some residents of the Lake Tonetta Association want the Board to consider other options. The residents feel it's brutal and inhumane to kill the geese and find the sound of gunshots alarming. The Supervisor explained that this has been done for at least a decade. The town has a permit from the DEC. The DEC's recommended response to the problem of geese is to hunt them. The Town tried other options first, placing moving dog cut outs, screamer guns, and codling of the eggs, but all were ineffective. The president and vice president of the Lake Tonetta Advisory Committee explained the process and the seriousness of the situation, and how they want to keep the Lake open and clean. The recreation director also explained that she fills up two grocery bags each morning before the beach opens and swimming lessons start. The Supervisor stated that it's his responsibility to protect the health and welfare of the residents and children using these facilities. He suggested anyone concerned get involved and go to the meetings.

## <u>Discussion - Water and Sewer District Policy</u>

Supervisor Hay stated that there has been a lot of work done to settle the discrepancies with the water district billing and the Town now has a plan he believes is fair. There will be a resolution brought forth next meeting.
